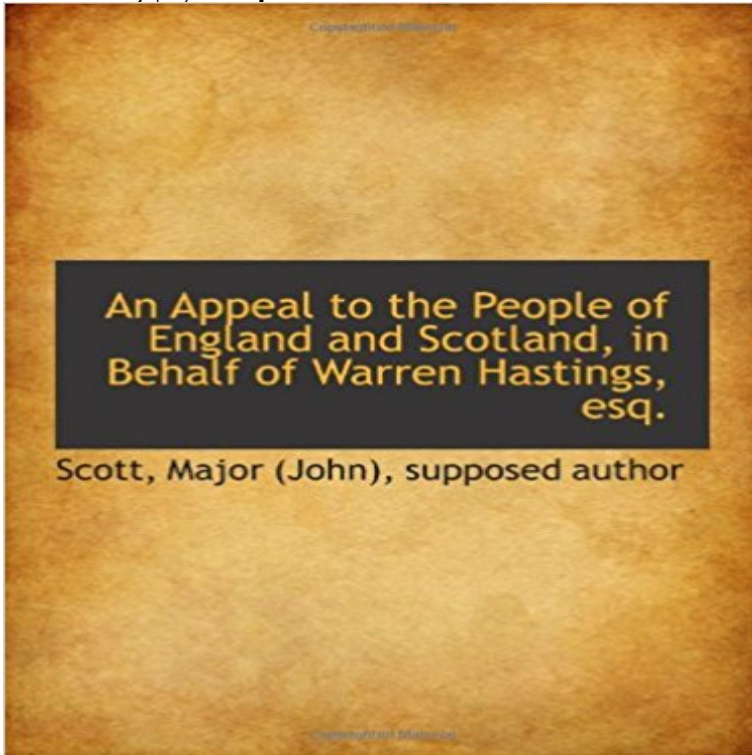


# An Appeal to the People of England and Scotland, in Behalf of Warren Hastings, esq.
