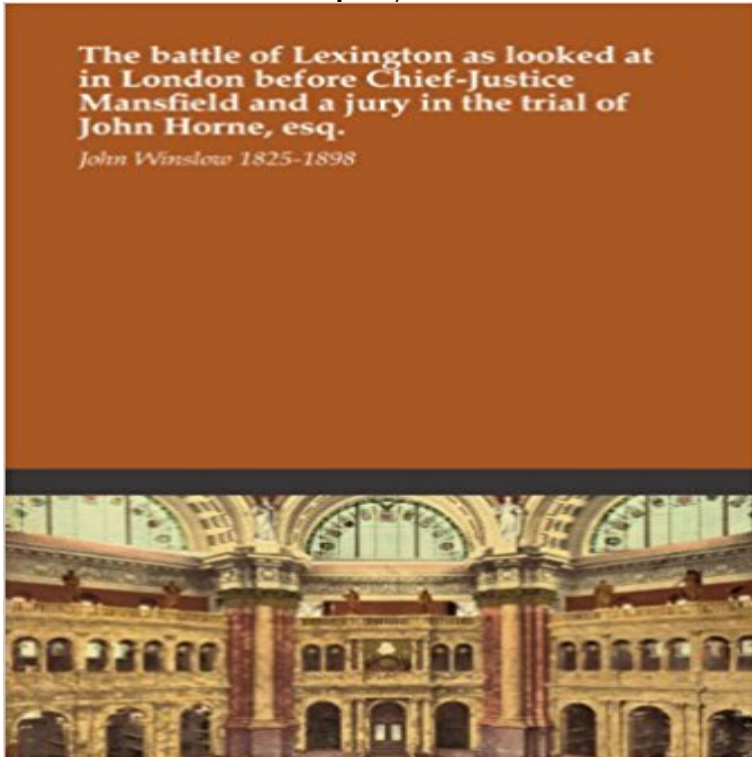


# The battle of Lexington as looked at in London before Chief-Justice Mansfield and a jury in the trial of John Horne, esq.
