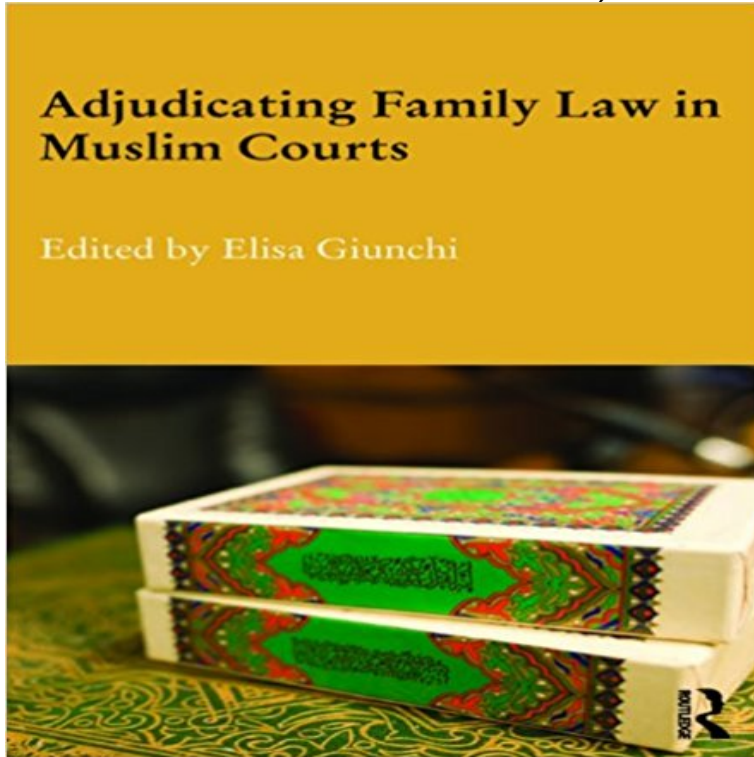


Adjudicating Family Law in Muslim Courts (Durham Modern Middle East and Islamic World Series)
