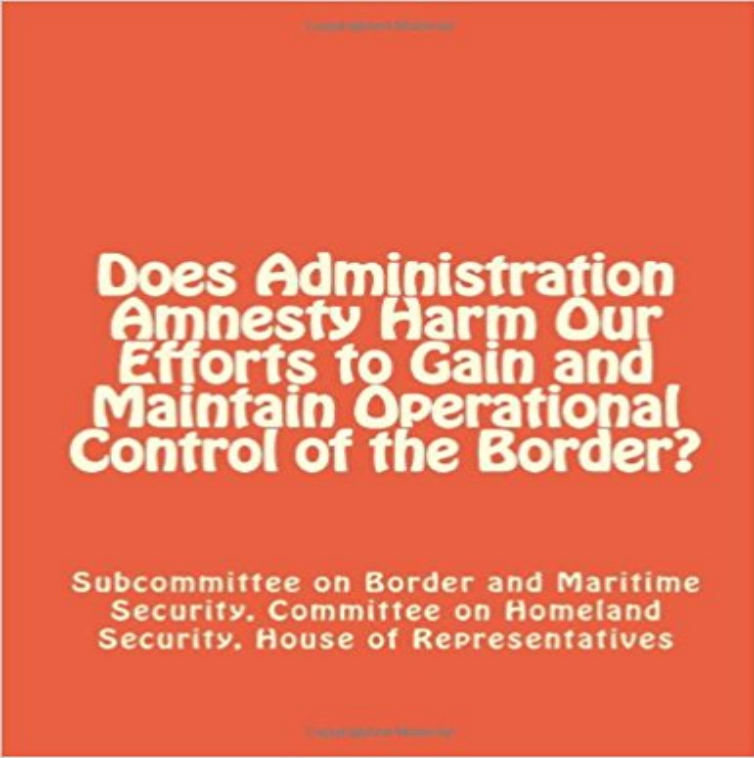


# Does Administration Amnesty Harm Our Efforts to Gain and Maintain Operational Control of the Border?
